

# Online competition rules

## -Complete online surveys and accumulate points-

### **Organiser:**

- The competition is developed and administrated by iSense Solutions International Research SRL, legally represented by administrator, hereinafter referred to as **organiser**.
- The competition will be carried out according to the hereby Rules, whose provisions are mandatory for all participants.

### **Definitions:**

The following terms, as used herein, will have the following meanings:

- "Winner" is the panelist who accumulates 3000 points in the surveys, click on the "Withdraw reward" button from his/her account and who will receive a \$30 (USD) reward.
- "Panel" is a platform in which any person who uses the internet may register voluntarily and agrees to take part in surveys on a regular basis
- "Panellist" is the person registered in the panel who fills in online surveys
- "Survey" or "questionnaire" refers to the online tool through which a panellist expresses his/her opinion on products or services which form the object of such survey or questionnaire.

### **Duration and area in which the competition takes place:**

- The competition takes place in several countries: Bulgaria, Croatia, Serbia, Slovenia, Albania, United States of America (USA), United Kingdom of Great Britain (UK), Germany.
- The contest takes place over a period of 12 months, being possible to extend it automatically with subsequent periods of 30 days, until the decision of the interruption organizer.

### **Participants**

- All persons with accounts on Sense Panels are registered in the competition.
- Any natural person over 16, having an account with a valid email address on Sense Panels and Active status in the panel (meaning that the person responds frequently to questionnaires, has a valid email address, an active account, his/her account has not been declared inactive, consented to the participation in surveys by means of the panel) can participate in the competition.
- If a Sense Panel member does not respond to a survey within 12 months after receiving invitations to surveys, iSense Solutions International Research SRL reserves the right to declare such person inactive. The organiser reserves the right to delete all members that were inactive for a year.
- Any member in the Sense Panel is free to express in any moment his/her wish to be removed from this panel. When a person decides to delete his/her account, the data of such person will be deleted from the database and such person will no longer be contacted. If she/he wishes, the person may re-register in the panel, but he/she will lose the score previously accumulated.

### **Mechanism of the competition**

- The persons who wish to participate in the competition must register on Sense Panels, accessing the registration form.
- The persons registered on Sense Panels shall receive invitations to fill in online surveys on the email address they used to register on the panel.
- For each survey they fill in, the participants are offered points. The number of points varies according to the duration of the survey.
- The invitations specify the duration of the survey and the corresponding number of points.
- Only persons with complete status for a certain survey (meaning persons qualified for the survey, persons who do not quit completing and who complete the questionnaire) will receive points.
- The number of points differs according to the duration of the questionnaire.
- The participants may also view their score after each survey in their panel account.

## **Rewards**

- An unlimited number of rewards amounting to \$30 (USD) is granted.
- The persons registered in the panel will receive \$30 (USD) when they accumulate 3000 points following the completion of online surveys and click on the "Withdraw reward" button from the account . 100 points represent the equivalent of \$1 (USD).

## **Procedure for granting the reward**

- The organiser receives a notification from the competition platform, when a panelist is classified as a winner and he/she requests the redemption of the prize, and asks him/her, through email, to provide the necessary information in order to receive the award (surname, name, bank account).
- The awards will be offered once per month, on the 18<sup>th</sup> day of the current month. If a participant accumulates 3000 points after the 18<sup>th</sup> day of the current month, he/she will receive the money on the 18<sup>th</sup> day of the following month.
- If the 18<sup>th</sup> day of the month is Saturday or Sunday, the money will be transferred on the first business day after the 18<sup>th</sup> day of the month. Possible delays of up to 10 business days may appear in the processing of the payment.
- If a person failed to send the necessary information for the validation of the payment until the 17<sup>th</sup> day of the current month, he/she will receive the money on the following month, with the mention that he/she must fulfil all conditions and the mentioned procedure.
- The identification information is necessary to make sure the winning person receives the award and to declare the award to the competent public authorities. The documents are kept in accountability, according to the law.
- After the withdrawal of the reward, the score of the panellist will be reset to 0, while after accumulating another 3000 points, he/she will be declared winner again.

## **Litigations:**

The hereby regulation applies to all participants to the competition organised by iSENSE SOLUTIONS INTERNATIONAL RESEARCH S.R.L, company incorporated in
